DID YOU KNOW?

If you are involved in a motor vehicle accident and the other vehicle is uninsured or has minimal coverage, you may not be able to receive fair and adequate compensation for your injuries. You can protect yourself for pennies a day by obtaining additional Supplementary Uninsured/Underinsured Motorist Coverage from your own automobile insurance company.

In order to receive no-fault benefits that will pay your medical expenses and lost wages after a motor vehicle accident, a no-fault application must be filed within 30 days with the insurance company of the vehicle you were operating or a passenger in, or if a pedestrian, the insurance company that insured the vehicle that struck you.

If you have an accident that involves the City of New York or other municipal entity, a Notice of Claim must be filed within 90 days of your accident.

Even before you have consulted with a lawyer, the insurance companies are already investigating your claim and preparing a defense, so call us right away... Time is of the Essence!

STEPS TO TAKE AFTER AN ACCIDENT

- Call our personal injury office immediately at the location nearest your home (see back cover) so we can assist you in filing a no-fault application, notice of claim, or other documents needed to protect your rights and bring a personal injury lawsuit.
- Seek medical treatment for your conditions immediately.
- Don't speak with anyone else about your case except your doctor or a representative from our office.

EXAMPLES OF RESULTS OBTAINED FOR CLIENTS:

\$875 million settlement on behalf of users of a drug that caused heart defects

\$816.45 million for toxic dust injuries sustained by firefighters, police officers and construction workers at Ground Zero
