DIRECTIONS

BRONX MEETING — BRONX OFFICE

From Hutchinson River Pkwy.:

South: Take to Westchester Ave. exit. Make a right onto Westchester Ave. (under the elevated subway) to Westchester Square subway station area. Make a left onto Commerce Ave. for 2½ blocks. Make a right turn onto parking lot (opposite side of street from DMV building). Make a hard left in parking lot and go to the far end to the Learning Center (you'll see UFT sign).

North (from Whitestone Bridge and Queens): Take to Tremont Ave./Westchester Square exit. Make a left onto Tremont Ave. —RIGHT ON STREET BEFORE BP GAS STATION. Make left onto Westchester Ave. (under elevated subway) three blocks. Make a left onto Commerce Ave. for 2½ blocks. Make a right turn onto parking lot (opposite side of street from DMV building). Make a hard left in parking lot and go to the far end to the Learning Center (you'll see UFT sign).

Bruckner Expwy. & Blvd. North: Take to Throggs Neck Bridge/Whitestone Bridge/Hutchinson River Pkwy/Zerega Ave. exit. Stay in extreme right lane and take Zerega Ave. exit. Turn left on Zerega Ave. to Waterbury Ave. Turn right on Waterbury Ave. to Commerce Ave. Turn left onto Commerce Ave. Turn left turn into parking lot (opposite side of street from DMV building). Make a hard left in parking lot and go to the far end to the Learning Center (you'll see UFT sign).

Cross Bronx Expressway: Take to Castle Hill Ave. exit. Make a left on Castle Hill Ave. exit. Make a right on Ellis Ave. to Commerce Ave. Make a left on Commerce Ave. approx. 2½ blocks. Make a left turn into parking lot (opposite side of street from DMV building). Make a hard left in parking lot and go to the far end to the Learning Center (you'll see UFT sign).

By bus (Take the following buses to Westchester Square): #8, #21, #31, #40 & #42

Walk three blocks east on Commerce Ave. Walk through the entrance gate on Commerce Ave. (between Halsey and Waterbury – opposite DMV building) to the far end of parking lot to the Learning Center (you'll see UFT sign).

By train: Take the #6 to Westchester Sq./E. Tremont Ave. station. Exit and walk three blocks east on Commerce Ave. Walk through the entrance gate on Commerce Ave. (between Halsey and Waterbury – opposite DMV building) to the far end of parking lot to the Learning Center (you'll see UFT sign).

NY & NJ DIRECTIONS

BROOKLYN & MANHATTAN MEETINGS - UFT HEADQUARTERS

By train:

#4/#5 (first car; last car from Brooklyn): Take to Wall St. station. Walk 1 block south to 52 Broadway.

R train (first car; last car from Brooklyn): Take to Rector St. station. Walk 1 block east to Broadway and 1 ½ blocks south to 52 Broadway.

J, M or Z (first car; last car from Brooklyn): Take to Broad St. station. Walk 2 blocks west on Exchange Pl. and turn left onto Broadway. Walk ½ block south to 52 Broadway.

#1/#9 (first car): Take to Rector St. station. Walk 1 block east on Morris St. Make a left onto Broadway and walk ½ block north to 52 Broadway.

#2/#3 (first car; last car from Brooklyn): Take to Wall St. station. Walk 1 block south on William St. to Exchange Pl. Make a left onto Broadway and walk ½ block south to 52 Broadway.

NY & NJ DIRECTIONS

QUEENS MEETING - FOREST HILLS JEWISH CENTER

From Brooklyn: Take the Belt Pkwy. (east) to Exit 19 from Van Wyck/Kennedy Airport. Van Wyck Expwy. (north), to Grand Central Pkwy. (west). Quickly move right to Exit 11 (69th Rd./Jewel Ave.). Take second ramp (69th Rd) to corner of 69th Rd and Grand Central Pkwy. Proceed four blocks down 69th Rd. Turn left onto Yellowstone Blvd. Turn left at traffic light on far side of Queens Blvd. intersection (approx. 20 feet after eastbound service lane of Queens Blvd. and immediately before Key Food). Proceed one block to 69th Ave. The Jewish Center entrance is located on the side of the building, down the ramp on 69th Rd.

From Manhattan: Take the Queens Midtown tunnel to the L.I.E. (east). Take the L.I.E. to Grand Central Pkwy. approx. 0.5 miles to Exit 11 (69th Rd./Jewel Ave.). Turn right at first light onto 69th Rd.. Proceed four blocks down 69th Rd.. Turn left onto Yellowstone Blvd. Turn left at traffic light on far side of Queens Blvd. intersection (approx. 20 feet after eastbound service lane of Queens Blvd. and immediately before Key Food). Proceed one block to 69th Ave. The Jewish Center entrance is located on the side of the building, down the ramp on 69th Rd.

From Long Island: Take the L.I.E. (west) to Exit 22A (Grand Central Pkwy.). Take the Grand Central Pkwy. (towards Kennedy Airport) approx. 0.5 miles to Exit 11 (69th Rd./Jewel Ave.). Turn right at first light onto 69th Rd. Proceed four blocks down 69th Rd. Turn left onto Yellowstone Blvd. Turn left at traffic light on far side of Queens Blvd. intersection (approx. 20 feet after eastbound service lane of Queens Blvd. and immediately before Key Food). Proceed one block to 69th Ave. The Jewish Center entrance is located on the side of the building, down the ramp on 69th Rd.

NY & NJ DIRECTIONS

STATEN ISLAND MEETING - LI GRECI'S STAATEN

From New Jersey:

Goethals Bridge: Take the S.I. Island Expwy. East toward the Verrazano Bridge. Get off at Clove Rd./Richmond Rd. exit. Turn left at first light onto Clove Rd. At Victory Blvd., turn right. Proceed approx. one mile (pass park) to Forest Ave. and turn left. The Staaten will be two miles on the right.

Bayonne Bridge: Get off at Forest Ave. exit. Proceed to the traffic light, make a left turn onto Forest Ave.. Proceed approx. three miles to the Staaten on the left.

Outerbridge Crossing: Take the West Shore Expwy. to the S.I. Expwy. , get off at Clove Rd./Richmond Rd. exit. Turn left at first light onto Clove Rd. At Victory Blvd., turn right. Proceed approx. one mile (pass park) to Forest Ave. and turn left. The Staaten will be two miles on the right.

From Brooklyn: Take the Verrazano Bridge and get off at Clove Rd./Richmond Rd. exit. Proceed to third traffic light along service road. Turn right on Clove Rd.. At Victory Blvd., turn right. Proceed approx. one mile (pass park) to Forest Ave. and turn left. The Staaten will be two miles on the right.

DIRECTIONS

NORTHERN NEW JERSEY MEETING - DOUBLETREE HOTEL

From NY: Take the upper level of George Washington Bridge. Merge onto Rte. 4W. Take Jones Rd. exit. Turn left onto Jones Rd. Merge onto Route 4E (via ramp). Hotel is on the right.

Rte. 80 East: I-80E to I-95N (local lanes). Take Exit 71 (Broad Ave.). Turn right at the end of exit ramp and follow Broad Ave. 3/10 mile. Turn right immediately before Rte. 4 overpass (sign for GWB); follow ramp up the hill and bear left onto Rte. 4E. Proceed a mile. Hotel is on the right.

Rte. 46 East: Rte. 46E to Fort Lee, take Palisades Pkwy. Exit (last exit in NJ). Follow signs to Rte. 4W. Take Rte. 4W approx. 1½ miles. Take Jones Rd. exit. Turn left onto Jones Rd. and another left onto Rte. 4E. Hotel is ¼ mile on right.

SOUTHERN NEW JERSEY MEETING - AMERICAN HOTEL

The Hotel is located off Route 18 and Route 9 South from the Garden State Parkway South, Exit 123. For door-to-door directions, please use GPS, Google Maps or Mapquest.

NY & NJ DIRECTIONS

WESTCHESTER/ROCKLAND/PUTNAM MEETING - CONGREGATION SONS OF ISRAEL

George Washington Bridge: Take the Palisades Pkwy. to Exit 9E. Take the NY State Thruway to Exit 11. Turn left onto Rte. 59 (which becomes Main St). Continue one mile to Broadway (fourth light). Turn left on Broadway. Synagogue is on the left (about ½ mile).

Tappan Zee Bridge: Take the NY State Thruway over bridge to Exit 11. Continue on High Ave. Turn right on Highland. Turn left at first traffic light on Main St. Turn left on Broadway. Synagogue is on the left (about ½ mile).

From NJ: Take the Garden State Pkwy. North to the NY State Thruway South to Exit 11. Turn left onto Rte. 59 (which becomes Main St). Continue one mile to Broadway (fourth light). Turn left on Broadway. Synagogue is on the left (about ½ mile).

NY & NJ DIRECTIONS

NASSAU COUNTY MEETING - ADELPHI UNIVERSITY

Northern State Pkwy.:

Traveling East - Take the Northern State Pkwy to Exit 26S (New Hyde Park Rd). Turn right onto New Hyde Park Rd. and continue south for three miles. Turn left onto Stewart Ave. At the fourth light, turn right onto Nassau Blvd. At first light immediately after crossing railroad tracks, turn left onto South Ave. Adelphi is on the right.

Traveling West - Take the Northern State Pkwy. to Exit 31S (Glen Cove Rd). Continue south on Glen Cove Rd. (turns into Clinton Rd.) for 2.3 miles. Turn right onto Stewart Ave. Go one mile and turn left onto Hilton Ave. Turn right onto Sixth St. (just over the railroad tracks). Continue onto South Ave. Adelphi is on the left .

Southern State Pkwy.: Take the Southern State Pkwy to Exit 17N (Hempstead Ave). Continue on Hempstead Ave. traveling north. Turn left at the second traffic light (Nassau Blvd). Continue north to the ninth traffic light (approx. 2 miles). Turn right onto South Ave. (immediately before crossing railroad tracks). Adelphi is on the right.

Long Island Expwy. (Rte. 495)

Traveling East - Take the L.I.E. to Exit 34S (New Hyde Park Rd). Turn right onto New Hyde Park Rd. Continue south on New Hyde Park Rd. (approx. three miles). Turn left onto Stewart Ave. At the fourth light, turn right onto Nassau Blvd. Continue approx. for a quarter of a mile. At the first light immediately after crossing railroad tracks, turn left onto South Ave. Adelphi is on the right.

Traveling West - Take the L.I.E. to Exit 39S (Glen Cove Rd.). Continue south on Glen Cove Rd. (turns into Guinea Woods Rd. to Glen cove Rd. to Clinton Rd). Turn right onto Stewart Ave. Go one mile and at T-junction and turn left onto Hilton Ave. Turn right onto Sixth St. (just over railroad tracks). Continue on South Ave. Adelphi is on the left.

By Train: The LIRR runs on a frequent schedule (travel time from NYC is 45 min.). Take the Hempstead Line from Penn Station in Manhattan or Flatbush Ave. Station in Brooklyn or Jamaica Station in Queens to the Nassau Blvd. Station. Adelphi is a short walk east on South Ave.

FLORIDA DIRECTIONS

BOCA/DELRAY & WEST PALM BEACH MEETING — SOUTH COUNTY CIVIC CENTER

From I-95 (North or South): Exit at Linton Boulevard. Travel west to Jog Road. Turn south on Jog Road. Turn left into the Civic Center parking lot. Before you get to the traffic light at Morakami Park Road.

From Florida's Turnpike (South): Exit at Atlantic Avenue. Go east to Jog Road, then South.

From Florida's turnpike (North): Exit at Glades Road. Go east to Jog Road. Travel north on Jog Road to the Civic Center, just past Morakami Park Road.

From State Road 441 (South): Turn left on Atlantic Avenue. Travel east on Atlantic Avenue to Jog Road. Turn right onto Jog Road and travel south to Civic Center.

From State Road 441 (North): Turn east onto Clint Moore Road. Travel on Clint Moore Road to Jog Road. Turn left and travel north to the Civic Center.

BROWARD MEETING — LEONARD WEISINGER COMMUNITY CENTER

From South of Atlantic Blvd.: Take State Rd. 7 (US 441) north to Margate Blvd. Turn left onto Margate Blvd. Turn left onto NW 58th Ave. At the end of the street, turn left on Park Dr. and an immediate right onto NW 10th St. Drive along NW 10th St. The building is the last one on the right.

From North of Atlantic Blvd.: Take State Rd. 7 (US 441) south to Margate Blvd. Turn right onto Margate Blvd. Turn left onto NW 58th Ave. At the end of the street, turn left on Park Dr. and an immediate right onto NW 10th St. Drive along NW 10th St. The building is the last one on the right.

FLORIDA DIRECTIONS

DADE MEETING — SURFSIDE COMMUNITY CENTER

From I-95: Take I-95 to the 125th St./Bal Harbour exit. Take 125th St. (Rte. 922) east to the Broad Causeway (toll). After the Causeway, continue on 96th St. to Harding Ave. Make a right turn onto Harding Ave. Turn left turn at 93rd St. The Community Center is directly ahead. Note: There are parking lots on 93rd Street.

From Collins Ave./A1A (from South Beach & Miami Beach): Take Collins Ave./A1A North to 93rd St. Community Center is on your right. Note: There are parking lots on 93rd Street.

From Collins Avenue/A1A (from Sunny Isles and Hallandale): Take Collins Ave. South. Collins Ave. becomes Harding Ave. Turn left turn at 93rd St. Community Center is directly ahead. Note: There are parking lots on 93rd Street.

OCALA MEETING — MARION COUNTY PUBLIC LIBRARY

5.5 miles East of Exit 352 on I-75, then Route 40

ORLANDO MEETING— EASTMONTE CIVIC CENTER

From I-4: Take Exit 92 to Altamonte Springs. Turn east onto SR-436 (East Altamonte Drive). Make a right onto S. Ronald Reagan Boulevard. Make a right turn onto Magnolia Drive. The Civic Center is on the left side of the road.

FLORIDA DIRECTIONS

TAMPA BAY MEETING - PINELLAS PARK CITY AUDITORIUM

From I-75:

Traveling South-

Take the Exit for I-275 South. Travel approx. 28 miles and take Exit 28 for FL-694 W toward Pinellas Park /Gandy Blvd. Merge onto FL-694 E /Gandy Blvd. Go 3 miles and turn right onto 59th Street N. In 0.1 mile the auditorium is on the left side of the road with the parking lot entrance immediately after the auditorium.

Traveling North-

Take Exit 228 for I-275 North. Travel approx. 27 miles and take Exit 28 for FL-694 West toward Pinellas Park. Follow signs for FL-694W and merge onto FL-694 East /Gandy Blvd. Go 3.6 miles and turn right onto 59th Street N. In 0.1 mile the auditorium is on the left side of the road with the parking lot entrance immediately after the auditorium.

FLORIDA WEST COAST MEETING - LAUREL OAK COUNTRY CLUB

From I-75: Take to Exit 207 – Bee Ridge Rd. Head east on Bee Ridge Rd. for approx. 3 miles (you will go through a few stop lights). At the stop light on Gary Player Blvd., you will see a large sign for Laurel Oak Country Club on your left. Turn in and head straight to the gatehouse. The guard will ask for your name and reason for arrival. From the gatehouse, follow signs for the clubhouse (it will lead you straight on Gary Player Blvd.). When you reach clubhouse, entrance is on the right.
