

## SAT and PSAT Updates for the 2022–23 School Year

Please review the information below and take appropriate action.

**PSAT and SAT School Day:** School-day administration of the SAT and PSAT will continue in the 2022–23 school year. Schools are expected to administer the PSAT to all students in grade 10 and the SAT to all students in grade 11 in spring 2023. The cost of school day administration of these exams in the spring continues to be fully covered by the DOE. Test dates are as follows:

- Schools may choose to administer the PSAT on any date(s) within the spring testing windows, **February 21–March 24** and **April 12–28**.
- SAT School Day is **March 22**, but schools may choose to administer the SAT to grade 11 students on the SAT School Day date(s) most convenient to their school community. The College Board has selected the following dates for spring 2023 SAT School Day administration: **March 1, March 22, April 12, and April 25**.
  - Note that **April 12** falls during spring recess.
  - The DOE discourages schools from selecting **April 25** as a primary test date because it is the final SAT School Day testing date, and in the event of city-wide or school-wide closures, an in-school make-up test date would not be available.

Additional details on ordering will be included in a future edition of Principals Digest; ordering deadlines begin in January. Additionally note that, as in previous years, students in non-traditional high school settings (e.g., transfer and international schools, Alternative Learning Centers, District 75 and 79) have additional flexibility in their SAT administration. Specific guidance on administering PSAT and SAT to students in non-traditional high school settings will be shared in a future edition of Principals Digest.

**Accommodations:** As in past years, administration and policies are overseen by the College Board. You must submit requests for testing accommodations via the College Board's SSD Online Portal. The College Board must approve all accommodations before students can receive them for College Board exams. Additionally, you must receive written consent from a student's parent or guardian before you can submit any requests for accommodations for that student. Deadlines to request accommodations are dependent on test administration date and begin in January. For consent forms and information on requesting accommodations for

**Digital Assessment:** The College Board [announced](#) a shift to digital-only administration of the SAT and PSAT beginning in the 2023–24 school year. The class of 2025 will be the first class to sit for the digital version of the exams. The DOE is working with the College Board to ensure that schools will be fully informed, prepared, and supported in making this transition.
